Treasurers Report 2025

It is my privilege to present the treasurer's report for the last year, remember the data/detail refers to April 1st 2024 to March 31st 2025 and pertains to our joint conference with WCET in Glasgow.

All the financial data is available on the ASCNUK website, in detail, and we remain in a healthy financial position, our income greater than our outgoings and with £54,185 profit for the year.

We are all, I am sure, experiencing cost of living challenges and ASCNUK are no different, income generation is more challenging and yet we are subject to cost rises across the board, part of my role is to try and navigate this to the benefit of the association and you, the members. One very simple example of this is the membership fee, we made a rise last year but will not make another this year, meaning that for £30 per year (or £2.50/month, or 58p/week, or .08p/day) you have access to all that ASCNUK offer, which I think you'll agree is value for money.

Therefore, we continue to try and make the most of all opportunities to ensure that that association remains solvent and relevant, I am sure you are aware we have a duty to you and are governed by the Charities Commission, to whom we are accountable. So, staying solvent isn't merely 'nice' it's essential for us to maintain charity status and continue to represent you, whilst responding and contributing to national events on your behalf.

I know my committee colleagues will reflect on the nationally driven projects, NICE: one piece closed bags for colostomies: late stage assessment https://www.nice.org.uk/guidance/hte29 and the Department of Health and Social care Part ix review of the drug tariff taxonomy, as well as the more recent NHSE review of the products and services so I will not dwell, but they are excellent examples of where ASCNUK represents and advocates for you and our patients.

Please, if you ever see such projects either externally or through ASCNUK do try and get involved, the more voices raised together the greater chance we have of being heard. Stoma care is poorly understood in the wider healthcare space, these reviews and assessments need your expertise and specialist knowledge, and I do feel it is part of our advanced role to get involved at a regional and national level.

To try and maximise income we, as a committee, constantly discuss and explore different options, including levying a charge when we receive external requests for access to our guidelines and project work. We feel there is merit in recognising that we have intellectual property rights and could be income generating, but we then always return to wanting to disseminate best practice as easily as possible because we are ultimately seeking to contribute positively to the profession of stoma care, globally. Likewise, we run webinars and education events, both to enrich members learning and professionalism and to raise the associations profile and income generate. Of course, as members these events are free to access and attend, please do continue to look out for them and interact with us about timings that you prefer etc., I know how hard to is to make time for 'extras' but we really value your attendance and input, we run them for you. On this note I would always welcome your views on these, and all aspects related to the association, please get in touch.



As I have said before, conference is our 'big earner', while the costs of hosting a joint conference were lower obviously our income was also reduced, although we did make a healthy £79,441 from WCET in Glasgow and we are very grateful to WCET for their partnership and the opportunity to collaborate on such a huge global event.

Joint conference was, I think you will agree, a huge success and it was really interesting to see presentations and practice from all around the globe. Your presence is vital, and you all make for an outstanding event, it was great to see you all networking and learning from each other. Our industry partners did us proud as did the charity sector and patient groups; conference is a demonstration of how much we have in common and how well we work together for the interests of ostomates and each other. We are always learning and, as a committee, we learn from each conference to try and improve year on year, your feedback is vital in this and whilst we cannot hope to please everyone ALL of the time we hope we get it right most of the time.

I am aware, from personal experience as well as reports from others, that claiming for funding to conference can be challenging, we do hope that this years 'packages' has improved this process for you. We must be MedTech compliant and accept the restrictions of this but try hard to minimise those for you. Any changes we make, are intended to make things easier for you to attend and our new secretariat Delegant, have brought with them fresh ideas and perspectives, again we would love to hear your feedback.

This year's conference will in beautiful Wales promises to be as full of educational enrichment and opportunities to learn, develop and enjoy so I am looking forward to welcoming you all to the ICC on the I2th October. I cannot fail to mention the two significant projects that ASCNUK are continuing to lead on and invest in.
